**OBSTRUCTIONS:** All artificially surfaced roads and paths including gravel and rock surfaced paths and roads and

reasonable extensions thereof including their artificial boarders. Buildings, sprinkler heads, vehicles,

stakes, player equipment, signposts, benches, walls, and fences (not marking boundaries) are either Moveable or Immovable Obstructions.
