16.1 as modified by Model Local Rule F-7 (sod seams) 16.1c(2) and 17.1d(2) as modified by Model Local Rule E-12 (Back On Line relief)

Course boundaries are defined by the following: White stake or lines and property fences.

BOUNDS: PENALTY ARFAS.

OUT OF

Penalty Areas are defined by RED lines.

DROPPING ZONE:

UNDER

REPAIR:

to the left of the green.

GROUND

In addition to areas circled by white lines, the following areas are ground under repair: - Large newly seeded areas with hay and nylon mesh (marked or otherwise)

NO PLAY

ZONE:

All cultivated flower & shrubbery beds - mandatory relief, no penalty All newly planted staked trees – mandatory relief, no penalty

OBSTRUCTIONS: All artificially surfaced roads and paths including gravel and rock surfaced paths and roads and reasonable extensions thereof including their artificial borders. Buildings, sprinkler heads, vehicles, stakes, player equipment, signposts, benches, walls, and fences (not defining boundaries) are either

Local Rule E-1.1 Dropping Zones on holes #18 as an additional option for relief from the cart path

Movable or Immovable Obstructions.

PACE OF PLAY: The published MGA Pace of Play Policy is in effect.
