All play will be from the **Black** tees (approx: 6564 yards). **Qualifiers:** *15* Alternates: 3

In the event of a tie for the last qualifying spot and/or the alternate spot, there will be a

hole-by-hole playoff immediately following play.

The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy and the following local rules govern play. NOTE: Disregard any and all local rules printed on the local

scorecard.

**FORMAT:** Two 9-hole rounds, stroke play. The MGA reserves the right to shorten the qualifying to 9

> holes if, for any reason, the full 18 holes cannot be completed. If this happens, results will be based on 9-hole scores with the available spots divided accordingly in the event of

a two-tee start.

Course boundaries are defined by the following: White stake or lines and property fences. Inside edge of Pavement/Curbing for roads or parking lot bordering the course.

Penalty Areas are defined by either **RED** or **YELLOW** stakes and/or lines.

When both stakes and lines are used to mark a Penalty Area, the stakes identify the while

the lines define the Penalty Area.

Model Local Rule B-2.1 has been adopted and allows for a drop on the opposite side of

a red penalty area. It may be found on the MGA Terms of Competition.

**DROPPING** Local Rule E-1.1 There are dropping zones for the following areas: **ZONES:** 

--Hole 2: For a ball in the red penalty area behind the green --Hole 7: For a ball in the red penalty area behind the green

In addition to areas circled by white lines, the following areas are *ground under repair:* - Model Local Rule F-7 - Ball in sod seams of newly sodded areas - lie of ball only

**NO PLAY** All cultivated flower & shrubbery beds - mandatory relief

**ZONES:** 

**OBSTRUCTIONS:** All *artificially surfaced* roads and paths including gravel and rock surfaced paths and roads and reasonable extensions thereof including their artificial boarders. Buildings, sprinkler heads, vehicles, stakes, player equipment, signposts, benches, walls and fences

(not marking boundaries) are either Movable or Immovable Obstructions.

PACE OF PLAY: The published MGA Pace of Play Policy is in effect.

*Note:* The time when a group is to finish hole has been printed on each official scorecard.
