## Local Rules & Information

Edina Country Club/ TEES: All players in the Players' & Mid-Players' Qualifier Divisions will play from the BLUE tees (approx. 6,395 Woodhill Country Club yards). Player's in the Senior Players' Division will play from the WHITE tees (approx. 6,031 yards). Vice President SPOTS: Players': 8 Alternates: 3 Paul Meierant, Mid-Players': Alternates: 2 3 The Playas Golf Club Senior Players': 1 Alternates: 2 Secretary/Treasurer TIES: In the event of a tie for the last qualifying spot and/or the alternate spots, an announcement will be made as Jerry Rose, to the playoff procedure. Options may include an on-course playoff (preferred). If conditions do not permit Alexandria Golf Club an on-course playoff, a scorecard playoff may be used. Past President **RULES:** The Rules of Golf, the MGA Terms of Competition, Pace of Play Policy, and the following local rules govern play. NOTE: Disregard any local rules printed on the local scorecard. Mike Malone. **Ridges at Sand Creek** FORMAT: Two 9-hole rounds, stroke play. The MGA reserves the right to shorten the qualifying to 9 holes if, for any reason, the full 18 holes cannot be completed. If this happens, results will be based on 9-hole scores with the available spots divided accordingly in the event of a two-tee start. REGIONAL **ELECTRONIC** The official method of scoring will be electronic by use of the **Golf Genius Mobile App**. Paper VICE PRESIDENTS scorecards will not be provided to players. Players should review the printed and video educational SCORING: information posted on the qualifying webpage to prepare in advance for this process. Also, players should Metro make sure their mobile devices are fully charged prior to beginning play. After completing your final Joe Conzemius, hole, all players and their markers should go to the Scoring Area immediately to certify their Interlachen Country Club scores. Jenny Malek, OUT OF Course boundaries are defined by the following: White stake or lines and property fences. Inside edge of Highland National Golf Club BOUNDS: Pavement/Curbing for roads or parking lot bordering the course. MLR A-5 is in effect if a ball goes out of bounds and comes to rest on another part of the golf course. Northeast PENALTY Penalty Areas are defined by either RED or YELLOW stakes and/or lines. Mike Stone. AREAS: When both stakes and lines are used to mark a Penalty Area, the stakes *identify* while the lines *define* the Crosswoods Golf Course Penalty Area. Northwest DROPPING There are no dropping zones in use during the qualifier. Glen Hasselberg. ZONE: The Vintage at Staples GROUND In addition to areas circled by white lines, the following areas are ground under repair: UNDER Model Local Rule F-7 - Ball in sod seams of newly sodded areas - lie of ball and area of intended swing Southeast **REPAIR:** only. Skip Hambright, Med City Golf Club NO PLAY ZONE: All cultivated flower & shrubbery beds - mandatory relief, no penalty. Southwest **OBSTRUCTIONS:** All artificially surfaced roads and paths including gravel and rock surfaced paths and roads and reasonable extensions thereof including their artificial boarders.
